

# TBIOS (GHealth.Ca, DrugQuery.Ca, TiiE.Ca) Privacy Policy (Global)

At TBIOS - Total Business Integration Operating Solutions Inc., We are committed to protecting and respecting your privacy. This Privacy Policy and the [Conditions of Use](#) sets out the basis on which any type of (personal/fitness/health) data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your (personal/fitness/health) data and how we will treat it.

## Information we may collect from you

We may collect and process the following data about you:

- a. Information that you provide by filling in forms on our Website or using Mobile applications, this includes information provided at the time of registering to use our Site, subscribing to our service/s, posting material or requesting further services. - e. Details of your visits to our Site and mobile applications including, but not limited to, traffic data, location data, your fitness & health data, weblogs and other communication data, whether this is required for our own billing purposes or otherwise and the resources that you access.

## IP addresses

We may collect information about your computer, including where available your IP address, Geo-location (Longitude/Latitude), operating system and browser type, for system administration and to report aggregate information to our advertisers. This is statistical data about our users' browsing actions and patterns, and does not identify any individual.

## Cookies

A cookie is a piece of information that a website transfers to the cookie file of the browser on your computer's hard disk so that the website can remember who you are and information about your visit. Our Site uses cookies to help provide you with a good experience when you browse our website and also allows us to improve our Sit

Third parties may also place and read cookies (or similar technology) on your browser to collect information or to serve content or advertisements to you.

We may disclose your (personal/fitness/health) information to:

- c. We may also disclose your (personal/fitness/health) information to third parties:
- d. In the event that we sell or buy any business, assets or shares, in which case we may disclose your (personal/fitness/health) data to the prospective seller or buyer of such business, assets or shares.
- e. If we are under a duty to disclose or share your (personal/fitness/health) data in order to comply with any legal obligation, or in order to enforce or apply our terms and conditions; or to protect our rights, property, or safety, or those of our customers or others.
